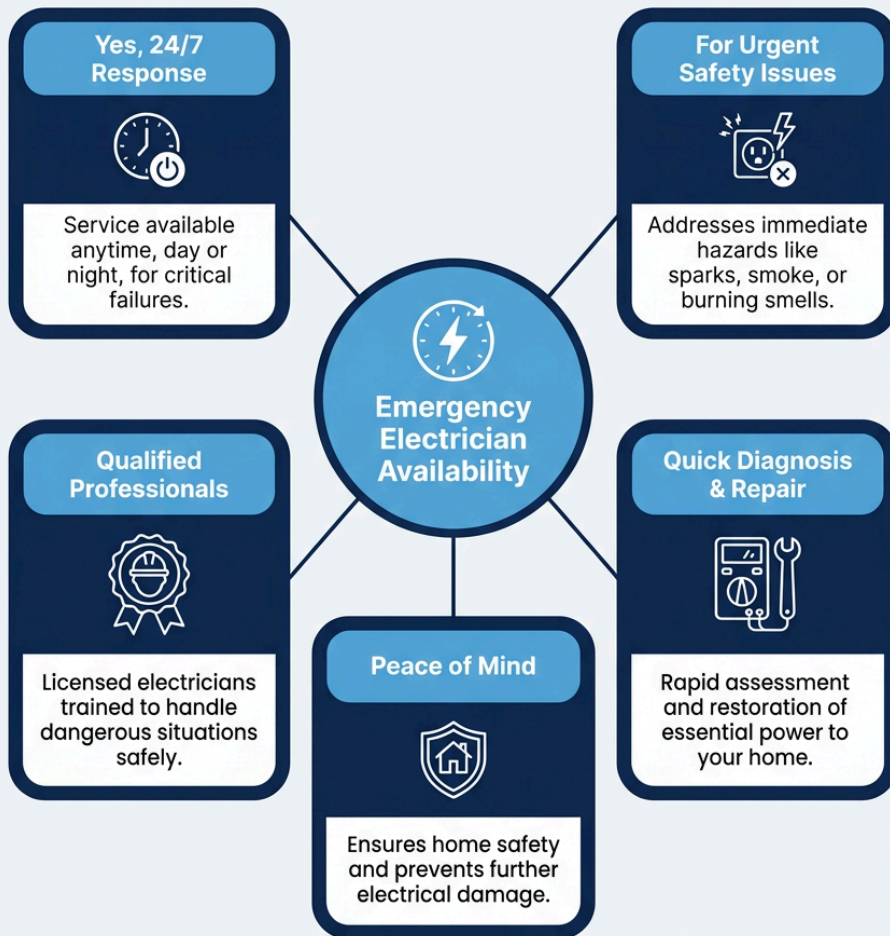
How Do Material and Labor Breakdowns Affect Your Emergency Quote?
