

Local search used to be relatively simple. A business claimed its Google listing, added a phone number, gathered a few reviews, and hoped to rank in the map pack. That approach still matters, but it no longer explains why one plumber appears consistently across Google Maps, voice search, and AI-generated search summaries while another, equally competent company barely shows up.

The difference often comes down to how clearly search systems understand the business as an entity.

That word, entity, sounds technical, but the idea is practical. Google and other search platforms try to identify real-world things: a law firm, a dentist, a roofing company, a neighborhood, a person, a service area. When they can connect those things with confidence, they become more willing to display that business for relevant local searches. When the signals are messy, incomplete, or contradictory, rankings become unstable.
