

Search used to be a simpler contest. A business needed a decent website, a claimed Google profile, a handful of reviews, and enough local citations to stay visible when someone typed "near me." That model has not disappeared, but it has been absorbed into a larger system where search engines, maps, voice assistants, and generative answer layers try to resolve entities rather than just rank pages.
