

A rideshare wreck raises a question a normal [atlanta personal injury attorney](#) car crash does not: whose insurance actually pays. The answer depends on what the driver was doing at that exact moment.

When the app is off, the driver is just a driver, and only the personal policy is in play. When the app is on and they are waiting for a ride request, a limited amount of coverage usually applies. Once they have accepted a ride or have a passenger in the car, a far larger commercial policy usually applies.

That timing is not a small detail. It can be the difference between a modest policy and a substantial one, and the app data that establishes it belongs to the rideshare company.

Whether you were riding, driving another car, walking or on a bike changes the analysis too. Each position can reach a different layer of coverage.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
