



Holistic care asks a simple but demanding question: what does this person need to function better, suffer less, and live with more stability? That question rarely has a single answer. A patient dealing with chronic pain may also be sleeping poorly, moving less, eating inconsistently, and carrying stress that keeps the nervous system on high alert. Someone in cancer treatment may need symptom relief, emotional support, better appetite, and enough comfort to stay engaged with the rest of their care plan.
