

How the Anion Gap Is Measured

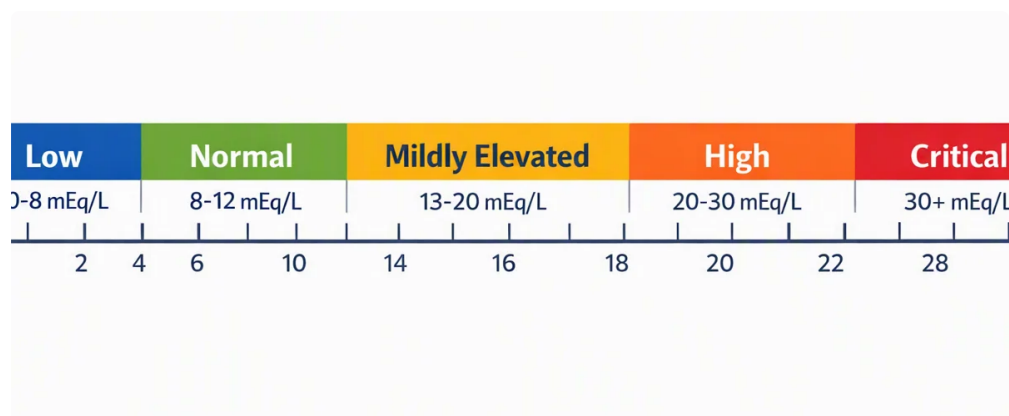
