If the app is off, it is an ordinary car wreck, and only the personal policy is in play. Once the app is on and the driver is waiting for a request, a smaller layer of coverage generally applies. Once a ride is accepted or a passenger is aboard, a far larger commercial policy usually applies.

That timing is not a technicality. It can decide whether the coverage available is modest or substantial, and the [truck accident lawyer](#) records that prove it sit with the rideshare company, not with you.

It matters whether you were the passenger, the other driver, a pedestrian or a cyclist. Each position can reach a different layer of coverage.
