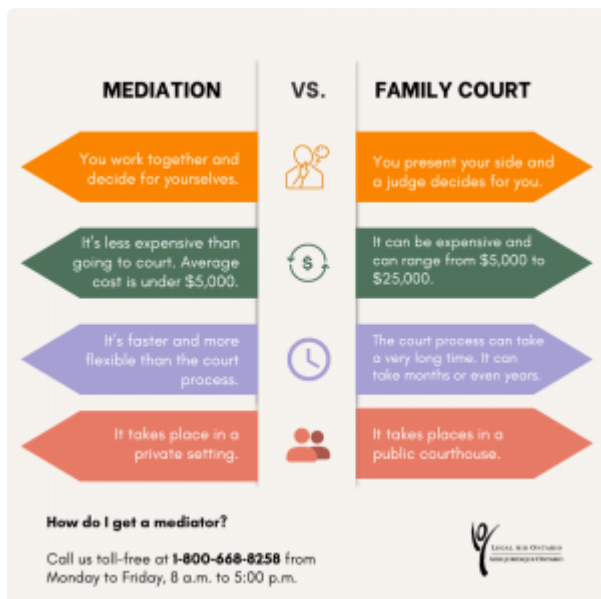
b) Major Decisions: One or both parents need to discuss and/or make major decisions impacting a child on issues such as education, religion, non-emergency healthcare, other matters.
