

If an electrical injury happened at work around Atlanta, the answer is rarely a single company.

A site has an owner, the general contractor, the electrical subcontractor, sometimes the utility, occasionally an equipment maker, and sometimes a staffing agency. Each carries its own coverage and its own reason to blame someone else.

Workers compensation pays medical bills and a portion of lost income when the injury is work related, and it prevents you from suing the employer directly. It does not bar a claim against a third [commercial truck accident lawyer](#) party whose conduct created the hazard.

That third party claim is usually where the real recovery sits, because comp does not pay for pain, disfigurement, or the full economic loss of a career that ended early.

Establishing who controlled the hazard requires the site contracts and the safety documentation, and none of that is available just for the asking.
