Incident reports are written by the party you will be making a claim against, which shapes what they contain. The store's own inspection records are just as important, since a written policy that was ignored says a great deal.

Most personal injury lawyers in Georgia work on a contingency fee, which means the fee comes out of the recovery instead of out of pocket. There is no attorney fee if there is no recovery.
