

Getting hit by an 18-wheeler is not a bigger fender bender. A fully loaded truck can outweigh your car many times over, and the injuries are usually far worse.

The difference shows up immediately. The trucking company often sends its own people to the scene within hours, before you are out of the hospital. They start protecting the company immediately.

How much does a personal injury lawyer cost in Atlanta?

Most personal injury lawyers in Georgia work on a contingency fee, which means the fee comes out of the recovery instead of out of pocket. There is no attorney fee if there is no recovery. Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
