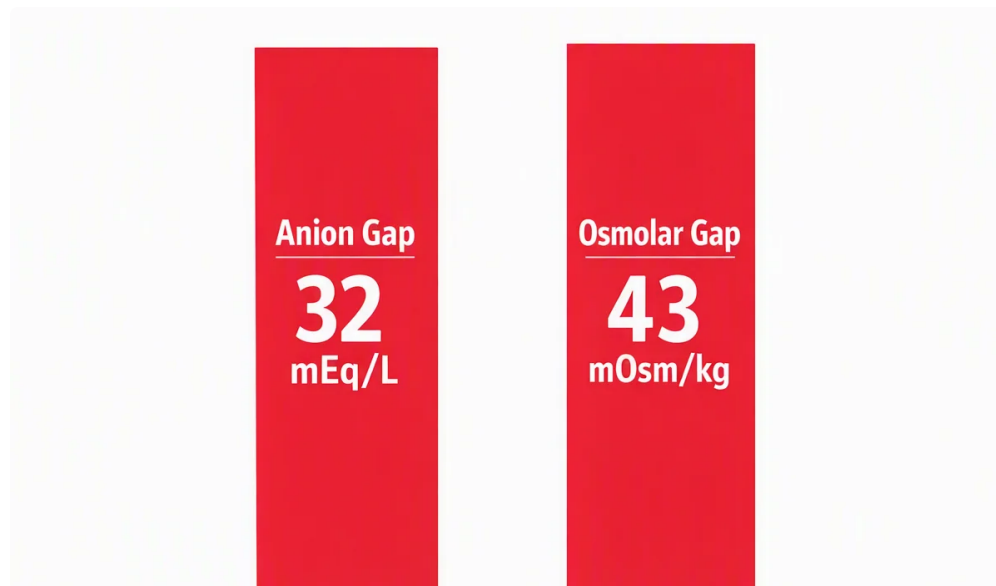

A common correction adds roughly 2.5 mEq/L to the anion gap for each 1 g/dL drop in albumin below normal, though exact formulas may vary. The key point is that albumin affects interpretation. ## Common Laboratory Findings in DKA

DKA often presents with a distinctive picture across blood sugar, bicarbonate level, and gas findings. A further pitfall is overlooking a mixed acid-base disorder. For example, vomiting can create a metabolic alkalosis that partially balances the acidosis. The delta gap can be useful for identifying this situation by comparing the rise in anion gap to the fall in bicarbonate.

The delta gap is especially useful when the clinical picture is confusing. If the gap is elevated more than expected relative to bicarbonate reduction, another metabolic process may be present.
