

If you or your child were bitten in **truck accident lawyer** Georgia, the rules may not be what you assume.

Some states hold the owner responsible no matter what. That is not the Georgia rule. The question is normally whether the owner knew the animal was dangerous, or whether the dog was loose in violation of a local leash ordinance.

Proving prior knowledge is difficult. People do not readily admit their dog has a history, and [18-wheeler accident attorney](#) witnesses on the same street tend to stay quiet.

The ordinance route is frequently more provable, which is why the first questions are about where the dog was and whether anyone contacted animal control.

Records disappear quickly here. County records and witness memory both degrade, and the animal may be rehomed or euthanized before its history is ever documented.
