

If a dog bit you in Georgia, Georgia works differently than people expect.

Certain states impose liability regardless of the animal's history. Georgia does not work that way. The question is normally whether the owner knew the animal was dangerous, or whether the dog was loose in violation of a local leash ordinance.

The knowledge route is hard to prove. Owners rarely volunteer that a dog has snapped before, and neighbors are often reluctant to get involved.

Local ordinance violations are usually easier to establish, so the early questions focus on whether the animal was restrained and whether a complaint was ever filed.

Records disappear quickly here. County records and recollections both fade, and the animal may be rehomed or euthanized before its history is ever documented.
