

If you or your child were bitten around Atlanta, the rules may not be what you assume.

Certain states impose liability regardless of the animal's history. That is not the Georgia rule. The claim generally turns on whether the owner had reason to know the dog was vicious, or whether the dog was loose in violation of a local leash ordinance.

Proving prior knowledge is difficult. Owners rarely volunteer that a dog has snapped before, and neighbors are often reluctant to get involved.

The ordinance route is frequently more provable, which is why the first questions are about where the dog was and whether anyone contacted animal control.

These records fade fast. Animal control files and witness memory both degrade, and the dog itself may be gone before anyone captures what it had done before.
