

If you were riding and were hit around Atlanta, there is a prior you have to overcome.

Adjusters and jurors bring an assumption to these cases: that the rider was going too fast, was lane splitting or weaving, or accepted a risk nobody else would.

Sometimes it fits. More often a driver looked and did not register a single headlight.
