

If a bus crash injured you in Georgia, the deadline may be far shorter than you think.

The general Georgia deadline for injury suits is two years. A claim against a city, county, transit authority or school district [commercial truck accident lawyer](#) can require written notice in a fraction of that time, and it has to be in the right form and go to the right place.

Missing that notice can end an otherwise strong case before it starts.
