

If an electrical injury happened at work in Georgia, there is usually more than one responsible party.

If the injury happened at work, workers compensation covers medical treatment and part of your lost wages, and it prevents you from suing the employer directly. It does not stop a claim against another company that caused the danger.

The claim against the other company is normally where the meaningful money is, since comp covers none of the human loss and only part of the financial one.

Establishing who controlled the hazard requires the site contracts and the safety documentation, none of which an injured worker can obtain by asking.
