

If a dog bit you around Atlanta, the legal standard surprises most people.

In some places an owner is liable automatically. That is not the Georgia rule. Usually it comes down to whether the owner had reason to know the dog was vicious, or whether the dog was loose in violation of a local leash ordinance.

Proving prior knowledge is difficult. Owners rarely volunteer that a dog has snapped before, and neighbors are often reluctant to get involved.

Local ordinance violations are usually easier to establish, which is why the first questions are about where the dog was and whether a complaint was ever filed.

Most personal injury lawyers in Georgia work on a contingency fee, which means the fee comes out of the recovery instead of out of pocket. There is no attorney fee if there is no recovery.
