

Whether dryer repair is worth it depends entirely on what's actually broken—and that's where most homeowners make costly mistakes. The real culprit might have been a faulty thermal fuse, a broken high-limit thermostat, or a clogged vent—each requiring a different fix. When Is Repair Actually Not Worth the Cost, and How Do You Know?
