

Local search looks deceptively simple from the outside. A business claims its profile, adds hours, gets a few reviews, and assumes the job is handled. Then six months pass and the phone is still uneven, map rankings move without warning, duplicate listings appear, and the owner has spent late nights trying to figure out why a competitor with fewer reviews keeps showing up first.
