If the app is off, it is an ordinary car wreck, and their personal policy applies. Once the app is on and the driver is waiting for a request, a smaller layer of coverage generally applies. Once they have accepted a ride or have a passenger in the car, a much larger commercial policy typically comes into play.

That timing is not a small detail. It can be the difference between a modest policy and a substantial one, and the records that prove it sit with the rideshare company, not with you.

Whether you were riding, driving another car, walking or on a bike changes the analysis too. Each one can reach different policies.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer. Trucking companies often send their own investigators to the scene within hours, and evidence such as onboard data and camera footage can be overwritten or lost in days.
