

If you were hurt by electrical contact in Atlanta, several companies may share responsibility.

There is the property owner, a general contractor, the **best personal injury lawyer** electrical subcontractor, sometimes the utility, sometimes an equipment manufacturer, and sometimes a labor supplier. Each carries its own coverage and its own reason to blame someone else.

If the injury happened at work, workers compensation covers medical treatment and part of your lost wages, and it bars a suit against your employer. It does not bar a claim against a third party whose conduct created the hazard.

The claim against the other company is normally where the meaningful money is, because comp does not pay for pain, disfigurement, or the full economic loss of a career that ended early.

Establishing who controlled the hazard requires the site contracts and the safety documentation, none of which an injured worker can obtain by asking.

Most personal injury lawyers in Georgia work on a contingency fee, which means the fee comes out of the recovery instead of out of pocket. There is no attorney fee if there is no recovery.
