

If you were hurt by electrical contact in Georgia, the answer is rarely a single company.

There is the property owner, a general contractor, the electrical sub, sometimes the utility, sometimes an equipment manufacturer, and sometimes a labor supplier. Each has different insurance and different incentives to point at the others.

If the injury happened at work, workers compensation covers medical treatment and part of your lost wages, and it bars a suit against your employer. The claim against the other company is normally where the meaningful money is, since comp covers none of the human loss and only part of the financial one.

Establishing who controlled the hazard requires the site contracts and the safety documentation, and none of that is available just for the asking.
