

What the Anion Gap Measures

The **anion gap** is a reliable way to interpret **serum electrolytes** and think through **acid-base disorders**. Reduced Anion Gap Causes

A **reduced** anion gap is not as frequent but still worth noting. A common cause is **hypoalbuminemia**, since albumin supplies negatively charged proteins to the blood. A further cause is **multiple myeloma**, where abnormal proteins can change charge balance and affect measured values. Lab error is also common enough to consider first, especially if the value is surprising or inconsistent with prior results.
