

What the Anion Gap Measures in Kidney Disease

The **anion gap** is a simple way to estimate how much unmeasured acid is found in the body. In **renal disease**, that matters because impaired kidney function can disrupt **electrolytes** and lead to **metabolic acidosis**. The result is not a diagnosis by itself, but it is a helpful screening tool for understanding whether acid accumulation, electrolyte imbalance, or another metabolic disturbance may be present.

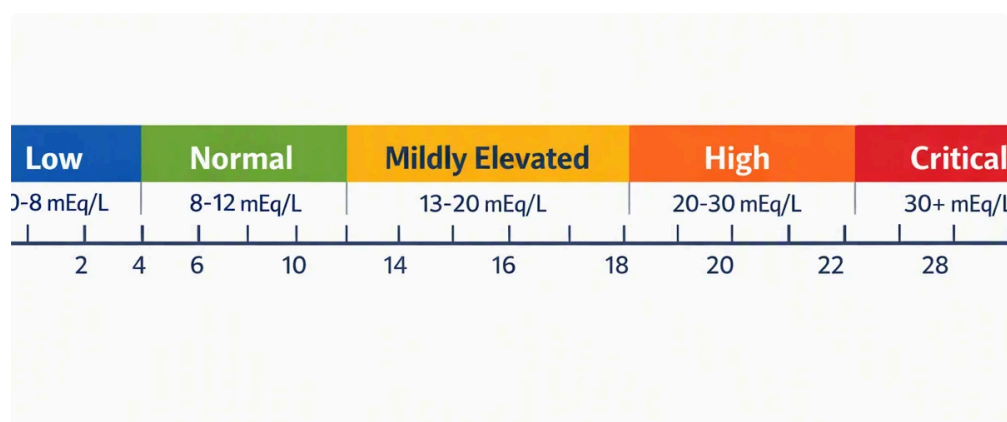
