

What the Anion Gap Assesses

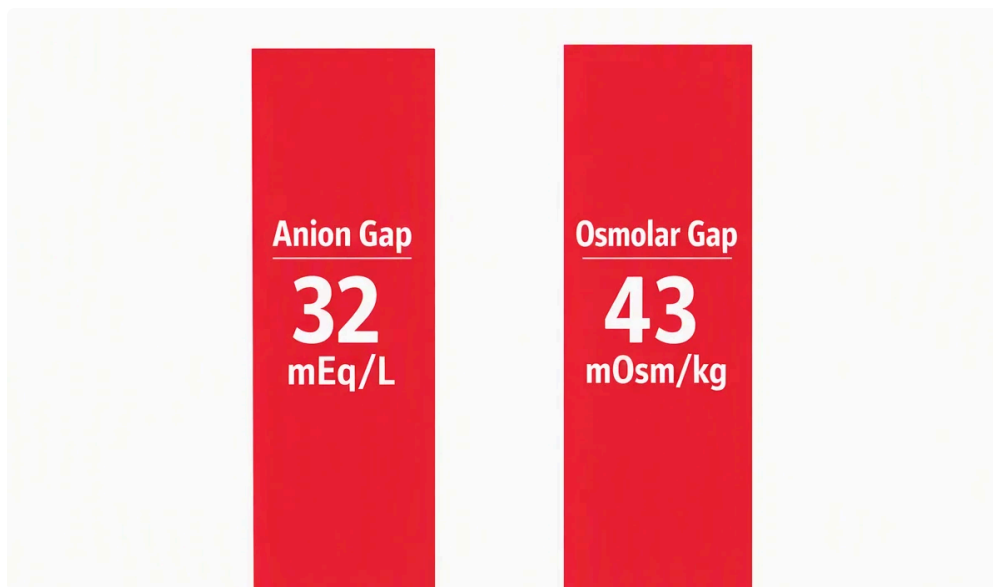
