

Losing someone in a preventable crash is not a legal problem first. It becomes one later, often when the bills arrive or an adjuster calls.

Georgia handles a death case differently than most people expect. There are generally two separate claims. One belongs to the surviving family and covers what the law calls the full value of the life that was lost. The other belongs to the estate and covers things like the final medical bills, the funeral, and any conscious suffering before death.

Georgia law sets an order for who may bring that first claim. A surviving spouse generally comes first, then children, then parents, and then the estate. When there is a [personal injury claim lawyer](#) surviving spouse and children, the law also sets a floor on the spouse's share.

Deadlines apply, and some of them are shorter than the general rule. A claim involving a city, a county or a state agency can require written notice long before a lawsuit is due. Evidence also disappears, especially when a company vehicle or a business is involved.
