

An **anion gap calculator** helps to interpret **blood test** results by estimating the difference between measured **electrolytes** in the blood. 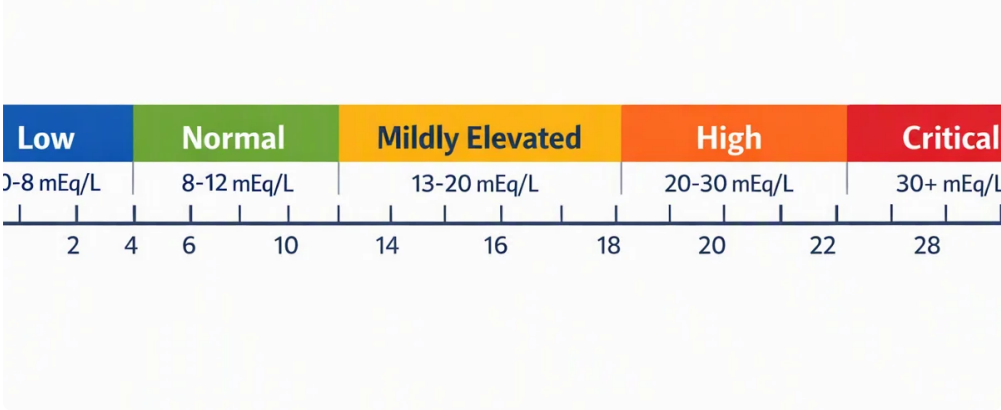
