

If you or your child were bitten in Georgia, Georgia works differently than people expect.

The ordinance route is frequently more provable, which is why the first questions are about where the dog was and whether a complaint was ever filed.

This evidence does not last. County records and recollections both fade, and the animal may be rehomed or euthanized before its history is ever documented.
