

If you or your child were bitten in the Atlanta area, the rules may not be what you assume.

In [atlanta personal injury attorney](#) some places an owner is liable automatically. That is not the Georgia rule. The claim generally turns on whether the owner had reason to know the dog was vicious, or whether the dog was loose in violation of a local leash ordinance.

Proving prior knowledge is difficult. People do not readily admit their dog has a history, and witnesses on the same street tend to stay quiet.

Local ordinance violations are usually easier to establish, so the early questions focus on whether the animal was restrained and whether a complaint was ever filed.

These records fade fast. Animal control files and recollections both fade, and the animal may be [experienced personal injury lawyer Atlanta](#) rehomed or euthanized before its history is ever documented.
